1.0 Background

1.1 Parking space markings in chapter house yard are currently non-existent making it very difficult for the Minster Police to find spaces for vehicles.





2.0 Option 1:

- 2.1 The surface is to be cleaned and all moss removed.
- 2.2 The lines to be installed are green thermoplastic to state electric vehicle parking with a white electric vehicle logo installed in each bay. A blowtorch heats the thermoplastic, which will stick the thermoplastic to the ground.
- 2.3 The parking spaces to be made larger leaving enough access around each vehicle. Gov sizes are W2.4m L4.8m & 1.2m Access zones
